NOTES TO FINANCIAL STATEMENTS

1. Summary of Significant Accounting Policies

A. Accounting Practices

The financial statements of Envision Insurance Company (Company) are presented on the basis of accounting practices prescribed or permitted by the Ohio Department of Insurance (ODI).

The ODI recognizes only statutory accounting practices prescribed or permitted by the state of Ohio for determining and reporting the financial condition and results of operations of an insurance company and for determining its solvency under the Ohio Insurance Law. The National Association of Insurance Commissioners' (NAIC) Accounting Practices and Procedures Manual, (NAIC SAP) has been adopted as a component of prescribed or permitted practices by the state of Ohio. There is no deviation from the NAIC Accounting Practices and Procedures Manual.

On June 29, 2017, Rite Aid Corporation, the parent company of Envision Insurance Company, and Walgreens Boots Alliance (WBA) mutually agreed to terminate their existing merger agreement, set forth October 2016, and enter into an asset purchase agreement in which Walgreens Boots Alliance (WBA) will acquire stores, related distribution assets and inventory from Rite Aid. Envision Insurance Company and its parent and affiliates under Envision Pharmaceutical Holdings LLC are not part of the new agreement and will remain wholly owned subsidiaries of Rite Aid Corporation.

State Guaranty Association Assessment

Insurers licensed to do business in a state are required by law to be a member of the state guaranty association. Guaranty associations provide for the payment of covered claims arising from the insolvency of insurers and are funded through assessments on solvent insurer members per state law. These assessments are based on each member's share of premium during the prior three years. The Company received an assessment of \$462 thousand from a state guaranty association related to the insolvency of several life and health insurers. All premiums of the Company included as the basis for the assessment were under the Medicare Part D program. Federal law prohibits assessments imposed by states on any payment made by the Centers for Medicare and Medicaid Services (CMS). In April 2017, the Company paid and expensed the assessment to avoid potential penalties and sanctions and filed a written appeal of the assessment with the guaranty association asserting that state law is preempted by federal law and Medicare Part D is not a health insurance policy regulated by the state. In June 2017, the guaranty association denied the appeal and the Company is in process of filing a second appeal with the state insurance commissioner as permitted by state law.

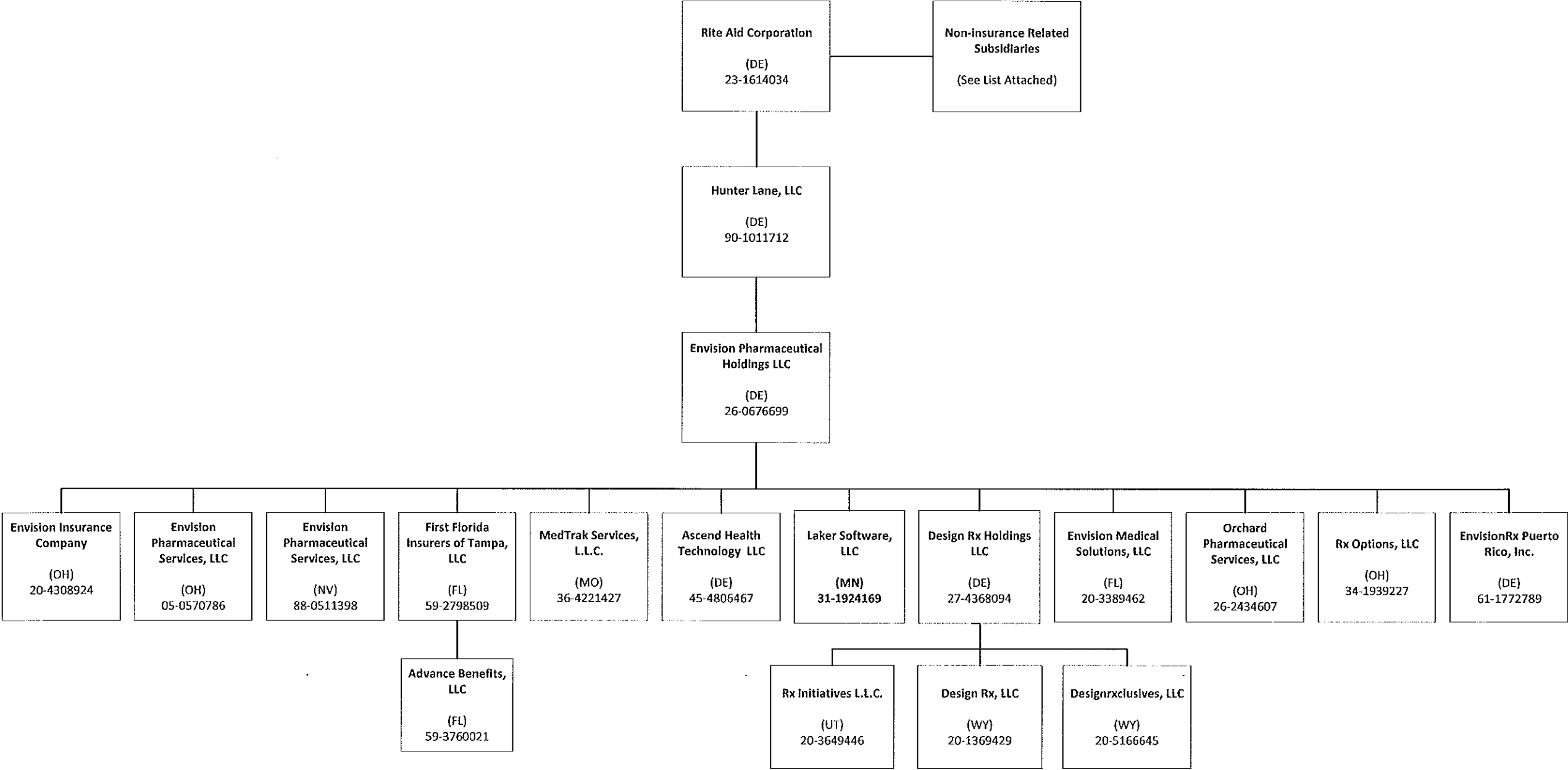
