Title 23 - Public Utilities and Regulated Industries

Subtitle 3 – Insurance

Chapter 61 - State Insurance Department

Subchapter 1 - General Provisions

§ 23-61-101 - State Insurance Department -- Continuation -- Assignment of space.

23-61-101. State Insurance Department -- Continuation -- Assignment of space.

(a) There is continued at the seat of government of this state an office or department designated as the State Insurance Department.

(b) Suitable space shall be assigned for the use of the department.

(c) (1) (A) The purpose of the department is to serve and protect the public interest by the equitable enforcement of the state's laws and regulations affecting the insurance industry.

(B) The primary mission of the department shall be consumer protection through insurer solvency and market conduct regulation, and fraud prosecution and deterrence.

(2) Nothing in this subsection shall be construed to limit the Insurance Commissioner's authority as enumerated in other provisions of the Arkansas Insurance Code.

MESSAGE FROM THE COMMISSIONER

It is my honor to present my first Annual Report as the Arkansas Insurance Commissioner.

I am proud to report that Arkansas continued to aggressively recruit new companies to do business in our state. We welcomed 22 new companies in 2019, pushing our total to 107 new businesses since 2015.

I am further proud to report that we **increased individual agent licensure by nearly 7.3%** in 2019. At the end of 2019, the Arkansas Insurance Department licensed **145,185 insurance producers and adjusters**. At the end of 2019, the Department licensed 10,215 business agencies, a 5% increase from 2018.

The growth of producers and businesses in 2019 resulted in **\$17.17 billion** in gross direct written premium for the year, a **\$2 billion** increase over 2018.

Since 2015, the Arkansas Insurance Department has increased direct written premiums in Arkansas by **\$4.49 billion**.

While the Department increased opportunities for the insurance industry in 2019, it also made bold moves to protect consumers and do right by Arkansas taxpayers. In 2019, our Consumer Services Division **recovered more than \$3 million** for Arkansas policyholders while AID's Life Policy Locator **reunited families with \$5.32 million** in lost life insurance policies or annuities.

We continue to stay true to our mission of protecting Arkansas consumers by providing timely assistance and information while we efficiently regulate the insurance industry's market behavior and financial solvency.

The Accounting Division collects and oversees fees and premium taxes from all insurance companies conducting business in the State of Arkansas. It also handles all purchasing and accounts payable to the Department, and develops our annual budget.

The Arkansas Insurance Department is a dedicated funding agency, meaning that it derives none of its operating revenue from either premium tax collections or general revenue.

The agency is funded by fees and assessments imposed on entities regulated by the Department which are deposited in the Insurance Department Trust Fund.

Companies pay insurance premium taxes using the *OPTins* online service, which can be accessed via the Department's website. Taxes collected by the Department are deposited in the General Revenue Fund, Arkansas Works Trust Fund, and other funds as designated by statute.

The Compliance Division is responsible for monitoring and regulating the rate and form filing activities of all insurance companies transacting business in the State of Arkansas. Insurers selling Life, Health, Property, and Casualty coverage in Arkansas must submit their forms for approval. These forms are reviewed to ensure compliance with state laws.

Insurers also must file the rates that they charge for insurance for most health, property, and casualty personal lines of insurance, as well as workers compensation and professional malpractice coverages.

Insurers file form and rate requests to the Arkansas Insurance Department (AID) through the System for Electronic Rate and Form Filings (SERFF) provided to the Department by the National Association of Insurance Commissioners (NAIC).


AID makes the non-proprietary portions of these filings available to the public through SERFF via link on the Department's website. The public can view filings conveniently from their home, office, or anywhere they have access to a computer, free of charge.

CONTINUED DECLINE IN WORKERS' COMPENSATION RATES

A dramatic decrease in the number of work-related injuries in past years has resulted in a decrease in the cost that a majority of Arkansas employers pay for workers' compensation insurance.

The significant rate reduction shows that policies in Arkansas are making it a welcome place for business and new employment opportunities.

The Department recognizes our state's employers and workers who mind workplace safety to keep costs low.

The Consumer Services Division (CSD) assists insurance consumers with complaints and inquiries regarding insurance companies, producers, and adjusters. CSD investigates all complaints and works with insurance companies and consumers to determine the appropriate course of action.

In 2019, it recovered \$3,011,014 for Arkansas consumers.

CSD also travels across the state to provide educational information and materials to Arkansans with questions about insurance.

In the event of significant storm damage or catastrophic events, CSD travels to the damaged areas to assist homeowners with filing claims and procuring emergency living expenses from their insurers, as well as helping with any other insurance related issues.

The Criminal Investigation Division (CID) investigates and prosecutes all categories of insurance fraud. CID was created by the Arkansas General Assembly in 1993 to investigate workers' compensation fraud.




In 1997, the Legislature expanded CID's mandate to include all other types of insurance fraud and in 2001, CID received full law enforcement status and statewide jurisdiction.

Investigations that result in a finding of a criminal violation are referred to the appropriate prosecuting attorney's office. Division attorneys are authorized to be appointed as special deputy prosecuting attorneys.

Insurance fraud is not a victimless crime. Every year thousands of Americans fall prey to the schemes that cost them their hard earned money.

It is estimated that insurance fraud costs Americans \$80 billion to \$120 billion a year.



The primary goal of the Finance Division is to protect Arkansas insurance consumers through effective solvency regulations. This is performed by monitoring the financial condition of all domestic and foreign insurance companies doing business in the state.

The Finance Division conducts financial and market conduct examinations and reviews other financial information. It also reviews reports filed by insurance entities, including business plans, reinsurance agreements, merger and acquisition documents, company formation documents, and market research and feasibility studies.

Insurance companies doing business in Arkansas must file annual financial statements with the Finance Division. These statements are available to the public online to download.






TOTAL PREMIUM VOLUME BY CALENDAR YEAR




ADMITTED PREMIUM BY CALENDAR YEAR



LIFE/ANNUITIES PREMIUM BY CALENDAR YEAR




PROPERTY/CASUALTY PREMIUM BY CALENDAR YEAR



RISK RETENTION GROUP PREMIUM BY CALENDAR YEAR






DOMESTIC FINANCIAL EXAMINATIONS




DOMESTIC FINANCIAL ANALYSIS

The Legal Division conducts research and offers counsel for the purpose of representing the Commissioner, AID staff, and the Department in legal proceeding.

Other duties of this division include drafting legislation, rules, bulletins, legal opinions, and conducting consumer complaint investigations.

The division also maintains the corporate records of insurers, including name and address changes, and domestication status. Division attorneys represent the Department in administrative hearings and court appeals pertaining to licensees' alleged insurance code or rule violations.

The Legal Division also provides counsel to the State Board of Embalmers, Funeral Directors, Cemeteries, and Burial Services following the passage of Act 788 of 2017. Additionally, division staff handles complaints against Pharmacy Benefit Managers following the passage of Acts 1 and 3 of the Second Extraordinary Session of 2018.

The Legal Division collected a total of \$ 338,022.95 in fines and penalties for 2019. It collected a total of \$500,562.22 in restitution/recoveries for Arkansas consumer for 2019.

The License Division is responsible for licensing resident and non-resident producers, adjusters, and business entities that solicit or sell insurance in the State of Arkansas.

The division licenses the following: Producers; Adjusters; Consultants; Surplus Lines Producers; Title Insurance Agents; Third Party Administrators; and Viatical/Life Settlement Providers and Brokers.

All licenses are renewed annually on the date of birth of the individual, and agencies are renewed on October 1 each year. Arkansas requires insurance carriers to appoint both individuals and business entities that will be selling for the company.

The division also conducts criminal background checks on all new resident applicants prior to approval for examination for licensure.

The Liquidation Division, acting on behalf of the Insurance Commissioner as Receiver, manages the day-to-day affairs of insolvent insurance company estates and insolvent prepaid funeral benefit trusts.

Although the division performs certain functions on behalf of the Commissioner, individuals employed with the division are not employed by the State of Arkansas.

The Liquidation Division does not receive any funding from the State of Arkansas. The division administers the Arkansas Life and Health Insurance Guaranty Association (ALHIGA) and the Arkansas Property and Casualty Guaranty Fund (APCGF).

In 2019, the division did not initiate and liquidations or rehabilitations pursuant to Ark. Code Ann. § 23-61-112.

The Public Employee Claims Division (PECD) is responsible for the investigation and management of workers' compensation claims filed each year for Arkansas state employees.

Workers' compensation coverage is also provided for emergency service volunteers who are accidentally injured while performing services under the call and supervision of the State of Arkansas or its political subdivisions.

PECD has partnered with the UAMS College of Pharmacy to create the Evidence-Based Medicine Program. The program approves or denies non-formulary prescriptions for workers' compensation claims involving state employees and has led to a reduction of state employee prescription costs. In September 2019, the Public Employee Claims Division won the national State Risk Manager Association Award For Innovative Risk Management (AFIRM) for our evidence-based medicine pharmacy benefits program.

The Risk Management Division was established to minimize the cost of insurance and fidelity bonding to state and school agencies and to analyze and make recommendations on loss prevention and safety programs to protect public assets.

In 2004, the Risk Management Division assumed the additional responsibility of providing insurance coverage, consulting, and loss prevention services to public schools that choose to participate in the Public School and Vehicle Insurance Trust Fund insurance plans.

The division is staffed with professionals who provide production underwriting and loss prevention services at no additional cost to participating governmental entities for the entire spectrum of the highly technical and complex areas of risk management of property, casualty and fidelity insurance. The knowledge and skills of the division staff have brought a high level of success to the programs managed by the division.

An extensive knowledge of governmental operation allows the Risk Management staff to provide consultant services as well as insurance and loss prevention experience at a minimal cost to taxpayers.

In the wake of ever-increasing cyber-attacks on governmental agencies, the Risk Management Division team has also added cyber liability insurance coverage for participating state governmental entities.

Risk Management also provides staffing for the Self-Insured Fidelity Bond Program and serve the Governmental Bonding Board. This self-funded program was established in 1987 and provides fidelity bond (employee dishonesty) coverage pertaining to hundreds of thousands of employees for all state, county, and municipal governments and public school districts in Arkansas.

ARKANSAS STATE VEHICLE SAFETY PROGRAM

The Risk Management Division, in cooperation with the DF&A - Office of Driver Services, also manage the State Vehicle Safety Program (VSP) pertaining to tens of thousands of drivers operating over 5,800 state scheduled vehicles.

The division also manages the state public school vehicle program for participating governmental entities operating over 5,200 scheduled vehicles.

The program involves record keeping and review of driver Traffic Violation Record information which is accessible on the DFA-Driver Services SVS website which fulfills underwriting and bid specification requirements.

The division updates the (VSP) when needed for underwriting purposes and achieve premium saving and market placement of the state's commercial fleet insurance.

All state agencies that participate in the Arkansas Multi Agency Insurance Trust (AMAIT) Fund vehicle insurance policy are required to participate in the VSP, as are all drivers operating a state vehicle or private vehicle on state business.

The division also offers an on-site advanced defensive-driving training program at no cost to the participating state agencies and public schools.







INSURANCE DEPARTMENT HISTORY



The work of the Arkansas Insurance Department was initially placed in the office of the Auditor of State by lay. The original “Insurance Bureau” was established in the Auditor’s office by the Act of April 25, 1873 with the Auditor being charged with the execution of the laws of the state relating to insurance.

Recognizing the greatly increased volume of work required to be done by the Insurance Bureau, the Arkansas General Assembly created the State Insurance Department via Act 190 on March 7, 1917. The Act created the Department headed by the Arkansas Insurance Commissioner appointed by the Governor with the consent of the Senate.


The first State Insurance Commissioner was Bruce T. Bullion of Conway who served from 1917 to 1924.


